**Dry Wipe Overlaminate** 



## **Product Description**

Metaguard 206 is a high gloss overlaminate and can be applied over printed Metamark digital media, to create dry wipe panels with printed graphics. The product is suitable for use with Dry Wipe marker pens only. The specially coated PVC film provides easy clean removal of dry wipe pens, and also offers good layflat dimensional stability. MetaGuard 206 is suitable for overlaminating prints on flat surfaces, for indoor use only.

### **Material Handling**

Ensure that the material has reached room temperature and a relative humidity of 50% before use.

#### Overlaminating

- Suitable for use on Solvent, Eco Solvent and Latex inkjet prints on Metamark print media
- Allow the inks to cure before overlaminating, this is usually 24-48 hours
- This product is suitable for cold lamination using a laminator. Apply around 30°C on the top roller to prevent silvering of the adhesive.
- Not suitable for wet application.

#### Use of product

- Test suitability of pens before use.
- Use soft non abrasive cloth to clean the surface.
- To remove any built up staining use warm soapy water and non abrasive cloth.
